Pursuant to a resolution adopted November 18, 2024, by the Board of Trustees, the sewer rates are hereby established for users' charges and debt service fees as required by Article VI of the District's Rules and Regulations and Chapter 6119 of the Ohio Revised Code. These rates shall apply to services effective March 1, 2025

## RESOLUTION # 11-18-2024-2

Pursuant to Article VI User Charge and Other System Charges, of the District's Wastewater Discharge Regulation and Chapter 6119 of the Ohio Revised Code, The Board of Trustees has conducted its annual review of the user charge system and amends the schedule of charges.

Bill Lawrence moved to adopt the following resolution:

Whereas the Board of Trustees is required by its rules, loan covenants, and governing Ohio statutes to provide for sufficient revenues to offset the costs of all transportation and treatment works operation and maintenance provided by the District and such other expenditures that may be authorized; and, Whereas the last rate increase was effective 3 years ago on December 1, 2022;

NOW THEREFORE BE IT RESOLVED,

1. That Article VI of the Wastewater Discharge Regulation shall be amended such that the monthly single family residential users charge shall be increased \$4.00 (8.33%) from \$48.00 to \$52.00 effective March 1, 2025, and that all other classes of user's charges shall be increased proportionally at the rate of 8.33%; and,
2. that, the 2025 Operating Spending Plan shall be approved.
